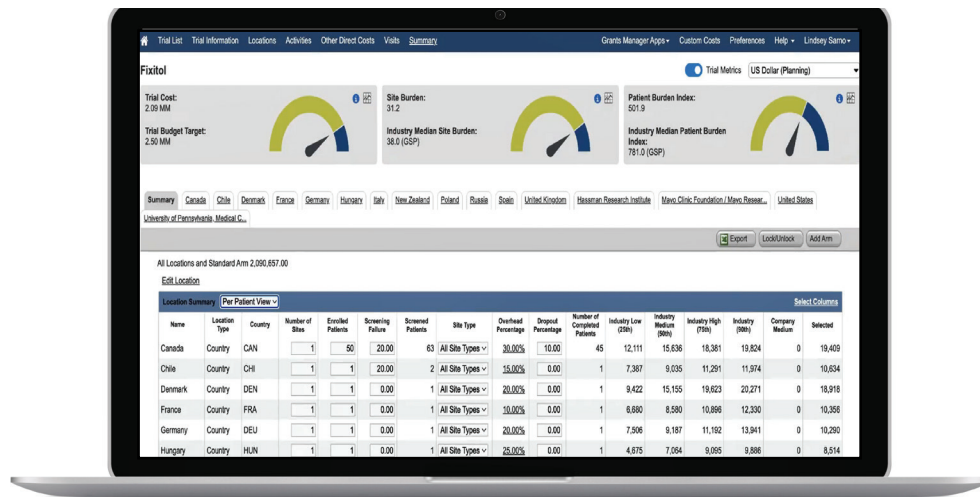

### Site Portal

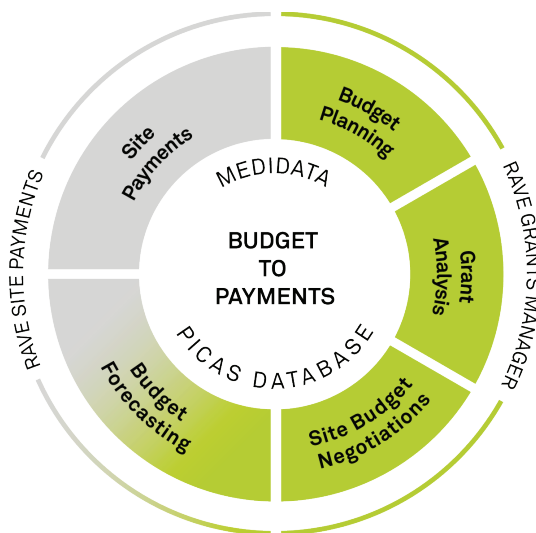
